# Follow-up solution for koelble & brunotte: PLUTA restructuring expert Ilkin Bananyarli finds investor for long-established fashion store in Stuttgart

From 13 June 2024 onwards, the city centre store will continue to offer premium womenswear and menswear from well-known brands as well as expert advice from a new address (Neue Brücke 3, Stuttgart), where customers will be able to buy items and consult with staff as usual. The current managing director will also remain on board. Mr Bananyarli, a specialist attorney, said, "I would like to express my gratitude for the good cooperation in recent weeks. Both staff and customers have stayed loyal to the business. This was an important prerequisite for the agreement now reached."

Effective 1 June 2024, the Local Court of Stuttgart opened the insolvency proceedings and appointed Mr Ilkin Bananyarli from PLUTA Rechtsanwalts GmbH as administrator. He had already been involved as provisional insolvency administrator since mid-March 2024.
