# Major investor interest in Fellensiek Group / PLUTA attorney Dr Christian Kaufmann to launch M&A process

Only a few days since Fellensiek Projektmanagement GmbH & Co. KG filed for insolvency, more than 50 parties have already registered their interest with provisional insolvency administrator Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH. KG and Fellensiek Beteiligungs GmbH. No other companies in the group are involved in insolvency proceedings and there is no obvious likelihood of these filing for insolvency or plans in this regard.

FPM alphabet capital GmbH & Co. KG has no employees and holds a stake in two companies that operate photovoltaic systems in various locations across Germany. Fellensiek Beteiligungs GmbH is the general partner of the project companies not affected by insolvency.
