# PLUTA attorney Dr Christian Kaufmann secures Waltron GmbH's future

Attorney Dr Christian Kaufmann, insolvency administrator for Waltron GmbH based in Warmsen, has found a follow-up solution for the company. The restructuring expert from PLUTA Rechtsanwalts GmbH has sold the business operations to Tropical Heimtierbedarf Deutschland GmbH from Ruhmannsfelden, Bavaria, effective 1 October 2024.

All 13 employees have been kept on by the new owner. The parties have agreed not to disclose any details concerning the purchase price.

Lighting system manufacturer Waltron has been involved in insolvency proceedings since late July 2024. On 1 October 2024, the insolvency proceedings were opened and Dr Christian Kaufmann was appointed administrator. He had already been acting as provisional administrator for the company prior to this. Together with his PLUTA team, comprising attorney Mr André Gildehaus and business lawyer Ms Nicole Neumerkel, Dr Kaufmann has been keeping the business operational since the application for insolvency was filed. The restructuring expert also launched a process to find an investor, which has now been successfully concluded. Waltron will be fully integrated into Tropical Heimtierbedarf Deutschland
