Dr Christian Kaufmann said, "This is an exceptional outcome for the creditors. We have only been able to achieve this rate thanks to the close cooperation and efforts of all involved."

The high rate is due to good realisation proceeds and the successful enforcement of legal claims, through which the administrator increased the insolvency estate for the creditors.

Ekowep GmbH & Co. KG operated a biogas facility. Its core business consisted of building and running a dry fermentation plant. The electrical energy generated there was sold to the relevant utility company. The plant also
