Our primary aim at this time is to ensure the care provider has a viable future. We are therefore reviewing various restructuring options, including the preparation of an insolvency plan, that might keep the care provider operating in the long term.” In addition to attorney Mr Brachwitz, the PLUTA restructuring team comprises attorney Mr Nicolas Konkel, who is helping the provisional insolvency administrator with the ongoing operation of the business.
