The Stuttgart-based attorney had already been involved as provisional administrator since 16 March 2026. He had been working in the meantime with his PLUTA colleague Mr Niko Maier to keep the business operating and conduct the process of finding an investor, which has culminated in the agreement achieved with ROM Technik.

We have concluded a purchase agreement with the investor that, among other things, ensures the transfer of all employees and the full retention of the site.
