Effective 1 March 2025, the newly founded Strahmann Food Concept GmbH will acquire the business operations and keep on everyone employed by the company, which was founded back in 1987. The new company will be headed by Mr Oliver Scheer, who was the operations manager for the previous business.

On 2 July 2024, the court opened the proceedings and appointed Ms Christiane Patricia Herweg as regular insolvency administrator. She had previously been involved as provisional administrator.
