current situation. Their salaries are guaranteed for a period of three months thanks to specific substitute benefits provided under German insolvency law. The company has primarily filed for insolvency on account of a liquidity shortage caused by declining orders and sales as well as persistently elevated costs. For some time now, the company has been feeling the effects of the general reluctance to invest, especially in the automotive sector, and of the weak economy.

Mr Georg Jakob Stemshorn from PLUTA said, "Our priority is to keep the business operational and reliably fulfil all ongoing orders. At the same time, we are analysing the company's financial situation and examining the restructuring options."

The specialist attorney will now initiate a structured process of finding an investor. "We will shortly begin reaching out to potential interested parties. Our goal is to find an investor for this family business," said the provisional insolvency administrator. In the PLUTA team, business lawyer Mr Maximilian König is responsible for keeping the company operational.

Managing director Mr David Abele said, "We need to restructure if we are to preserve our business. Our motivated staff are fully behind the company. We will now speak with our customers and suppliers as well and hope they will support us in these proceedings. The circumstances are far from easy, but I am confident that we will succeed in finding a long-term solution."
