PLUTA team achieves solution for Smileforyou MVZ orthopaedic practice

The PLUTA team has achieved an initial solution with an investor in the insolvency proceedings for the Smileforyou Group. Orthodenta Plus GmbH will acquire the two locations of Smileforyou MVZ GmbH in Göppingen and Eislingen by way of an asset deal and keep on all of the employees.

The acquisition took effect on 1 December 2024. The Local Court of Landshut opened the company's insolvency proceedings on that same day. Attorney Mr Daniel Barth was appointed regular insolvency administrator for Smileforyou MVZ GmbH, having previously acted as provisional administrator for the company.

The SMILIKE GmbH practice in Sinsheim has been sold to Dr Amr Ghali. Sales negotiations with interested parties are still ongoing for other SMILIKE locations and the practice of Dr Friedrich Widu. Mr Daniel Barth is the insolvency administrator for SMILIKE GmbH. The proceedings were opened on 18 December 2024. PLUTA attorney Mr Ivo-Meinert Willrodt has been appointed administrator for the practice of Dr Friedrich Widu. The attorneys are being supported in all three proceedings by business lawyer Mr Maximilian Wanko.
